



STUDENT PLEDGE FOR DIGITAL LEARNING DEVICES

I understand I am financially responsible for the iPad or MacBook Pro and its accessories.

1. I understand that I must pay the \$20 annual insurance fee, but if this fee creates a financial hardship, I will contact the campus for assistance.
2. I understand that in case of damage, \$50 deductible is applied for the first repair, and additional repairs may be charged at the full amount of the repair.
3. I agree to pay for the replacement of power cords and/or all accessories in the event any of these items are lost, stolen, or damaged according to the replacement cost chart below.
4. I will file a police report within three days in case of theft or vandalism.
5. I will report a lost device to the campus technology facilitator within 3 days.
6. I will be responsible for all damage or loss caused by neglect or abuse.
7. I agree to return my device, power cords and all accessories in good working condition immediately upon request by the District.
8. I will return the device issued to me at the end of each school year. If I withdraw, am suspended or expelled, or terminate enrollment at the campus for any reason, I will return the school-issued device and all accessories on the date of termination.
9. I agree to pay the replacement cost of the District-issued device and accessories if I fail to return it at the end of the school year or upon termination of enrollment.

I know that I will be issued an iPad or MacBook Pro each year, and I want it to be well maintained. Therefore:

1. I will follow Belton ISD’s Student Technology User Agreement and the Mobile Computing Device Guidelines.
2. I will never leave my device unattended, loan my device to other individuals, or take/use another student’s device.
3. I will bring my device to school daily, and it will be fully charged.
4. I will protect my device from scratches, food and beverages since they may cause damage to it.
5. I will keep the protective cover intact including any port covers and/or shield.
6. I will not disassemble or try to repair any part of my device possibly voiding the warranty.
7. I will install and maintain the District’s mobile device management system.
8. I understand that my device remains the property of Belton ISD, is subject to inspection/confiscation at any time without notice, and may be taken up by the campus.
